Official Rules

Entry

By entering the promotion, each entrant accepts and agrees to be bound by these Official Rules. No purchase necessary to enter or win. Members will automatically receive one (1) entry into the quarterly drawing for one of the following:

- (a) Joining the credit union, subject to membership eligibility;
- (b) Referring another individual who joins the credit union, as evidenced by information provided by referred member at time of account opening, subject to membership eligibility; or
- (c) Obtaining a loan from the credit union, subject to credit approval

For each of the above, the entry will be in the name of the primary member. Individuals may also enter by completing an entry ticket at a credit union branch. Entry will be included in quarterly drawing for the quarter in which the qualifying action was completed. Promotion may end at any time upon the close of a quarter at the discretion of the credit union.

Prizes

There will be one (1) winner each quarter who will receive \$500 deposited into their savings account at Cascade Federal Credit Union. Past quarterly drawing winners are not eligible to win in subsequent quarters. Each winner will be selected by random drawing from all eligible entries on or about the first business day following the quarter-end. Winners will be notified by phone or email during the month following quarter-end (April, July, October, and January). Winners are responsible for all applicable federal, state and local taxes. The prize is not transferable or assignable. Odds of winning depend on the number of entries received.

Conditions

The drawing is void where prohibited or restricted by law and is subject to all federal, state and local laws and regulations. All winners agree to the use of their names and likenesses in publicity without notice or any additional compensation, except where prohibited by law.
